### **FAIRFAX INDIA FILES FINAL UNIVERSAL SHELF PROSPECTUS**

Fairfax India Holdings Corporation (TSX: FIH.U, “Fairfax India”) has filed a final short form base shelf prospectus with the Canadian securities regulatory authorities.

The shelf prospectus allows Fairfax India to offer from time to time over a 25-month period up to US\$1.5 billion of debt, equity or other securities.
